#### **Deregulation by Defunding: The Need for State Alcohol Regulatory Funding**

## **Fireside Chat with TTB**

### Carrie May, Assistant Administrator for Permitting and Taxation, Office of Field Operations, TTB

Caroline 'Carrie' May currently serves as the Assistant Administrator, Permitting and Taxation, of the Alcohol and Tobacco Tax and Trade Bureau (TTB), where she oversees excise tax collection and application processing for TTB's regulated industries. Previously, Ms. May served as Assistant Administrator, Field Operations, where she was responsible for the oversight, direction, and coordination of Field Operations functions associated with TTB's tax collection and consumer protection programs. In Field Operations, Ms. May furthered the partnership between Field Operations and Permitting and Taxation to drive increased tax compliance and led TTB's tax simplification initiative. Prior to serving as Assistant Administrator, she was with TTB's Office of Chief Counsel, most recently as Assistant Chief Counsel (Field Operations).

Before joining TTB, Ms. May was a trial attorney with the United States Department of Justice (DOJ) Tax Division, where she represented the United States in federal district and bankruptcy courts in tax-related matters. Prior to working at DOJ, Ms. May was a litigation associate with the Washington, DC law firm of Patton Boggs, LLP.

Ms. May holds a Bachelor of Arts degree from the University of Louisville and a Juris Doctor degree from the University of Virginia. She is a member of the bar of the Commonwealth of Virginia, the District of Columbia, and the Commonwealth of Kentucky.

### **Legal Update: Checking in with The Supremes**

Thomas M. Fisher, Former Solicitor General, State of Indiana and current Vice President & Director of Litigation, EdChoice

Thomas M. Fisher served as a Deputy Attorney General for 22 years and as Indiana's first Solicitor General from 2005-2023. In that role he handled high profile litigation for the State, defended state statutes against constitutional attack, advised the Attorney General on a range of legal policy issues, and managed the State's U.S. Supreme Court docket. A two-time recipient of the National Association of Attorneys General Best Brief Award, Fisher has argued five times before the High Court.

His U.S. Supreme Court experience also includes authorship of dozens of cert-stage and merits-stage amicus curiae briefs on a wide range of issues. In addition, Fisher has argued dozens of important and high-profile cases before both the Indiana Supreme Court and the Seventh Circuit U.S. Court of Appeals. Fisher is a Fellow of the American Academy of Appellate Lawyers and was recently named a Sagamore of the Wabash by Governor Eric Holcomb.

A native Hoosier, Fisher is a graduate of Wabash College and Indiana University Maurer School of Law, where he serves as an Adjunct Professor of Law.

John Neiman, Former Solicitor General, State of Alabama and current Shareholder, Maynard Nexsen

Clients look to John Neiman in high-stakes cases that are on appeal or likely to get there. A former U.S. Supreme Court clerk and Solicitor General of Alabama, John chairs the Firm's Appellate Practice Group, which strives to provide clients the highest level of appellate advocacy at value-driven rates. Best Lawyers® has named him the region's "Lawyer of the Year" for Appellate Practice three different times—in 2017, 2021, and 2024.

At any given time, John has multiple cases pending in the Alabama Supreme Court and Eleventh Circuit. In recent years, John has helped clients obtain reversals by the Alabama Supreme Court of multiple jury verdicts, including an \$18 million verdict in one case and an \$11.4 million verdict in another. He also recently helped a client obtain reversal by the Alabama Supreme Court of discovery sanctions that otherwise would have required a judgment against it on a claim for wrongful death. He has successfully represented clients in the Eleventh Circuit multiple times, in cases involving claims in excess of \$50 million.

While he is a go-to lawyer for cases in the Alabama Supreme Court and Eleventh Circuit, John also represents clients in a wide array of appeals throughout the country. In recent years he has presented oral argument for insurance-sector clients in the highest courts in New York and California, as well as the Fourth, Seventh, and Eighth Circuits. John has appeared for alcohol-industry clients in the Supreme Court and the First, Fourth, Sixth, Seventh, Eighth, and Ninth Circuits. As state Solicitor General from 2011 to 2014, John orally argued two merits cases at the United States Supreme Court.

John also routinely serves as counsel at high-stakes trials, where the subject matter has varied from alleged bad-faith denial of insurance coverage, to claims of environmental contamination, to personal-injury claims, to securities litigation. In this role he helps trial lawyers—whether at Maynard Nexsen or other firms—preserve clients’ objections, argue motions for judgment as a matter of law, and otherwise posture the case for effective results on appeal.

John’s practice extends to constitutional and administrative challenges to legislation and agency action. He is currently part of a team that represents clients challenging the federal Corporate Transparency Act. As counsel for the State of Alabama in water litigation, he recently helped his client negotiate an agreement that—if adopted by the Corps of Engineers after a public-comment period—will set minimum-flow targets at critical points of the Chattahoochee River for the first time in history. He also was part of a team that successfully challenged the IRS’s listing notice concerning conservation easements.

John is a fellow of the American Academy of Appellate Lawyers. Chambers USA: America's Leading Lawyers for Business distinguishes him as a Band 1 leading attorney in the area of Appellate Litigation.

### Raimee Eck, Founder and Principal, Sonrisa Solutions

Raimee H. Eck, PhD, MPH, MPAS, CPH has over 20 years of clinical and public health training and experience, focusing on the epidemiology of alcohol use and harm, environmental interventions to reduce acute and chronic causes of alcohol-related harm, and translating research into effective policy. She also completed a Cancer Research Training Award Fellowship at the National Cancer Institute where she studied the role of alcohol in the development of cancer, the co-use of alcohol with other behavioral risk factors (e.g., tobacco), and points of intervention along the cancer control continuum. Raimee is a Past President of the Maryland Public Health Association and Past Chair of the Advocacy Committee, where she currently Chairs the statewide Alcohol, Tobacco & Cannabis Network, a coalition of researchers, legal experts, and community advocates. She is also

the founder and principal of Sonrisa Solutions, providing expertise on topics such as alcohol, tobacco, and cannabis epidemiology, regulation, and enforcement; public health policy translation; and advocacy in the form of research reports, workshops, and webinars. She also teaches Media Advocacy at the Johns Hopkins Bloomberg School of Public Health (JHSPH).

Raimee received her Bachelor of Health Science and Master of Physician Assistant Studies from Duquesne University in Pittsburgh, PA and her MPH and PhD from JHSPH.

**Preserving Fair Competition in Alcohol Regulation**

Matthew Botting, General Counsel, California Department of Alcoholic Beverage Control

Matthew Botting was appointed to the position of ABC General Counsel in August 2008. Mr. Botting has close to 30 years of state government legal experience. He was ABC's Chief Legal Counsel from 2000-2004 before he left for a short time to work in private practice. Mr. Botting returned to ABC in 2005, where he served as a Staff Counsel III until his appointment to General Counsel. Prior to joining ABC in 2000, Mr. Botting was a Deputy Attorney General with the California Department of Justice. Mr. Botting also represents the California ABC at the

National Conference of State Liquor Administrators (“NCSLA”) and served as President of that organization during 2016-17. He obtained his Bachelor of Laws and Bachelor of Commerce (Economics) degrees from Otago University in New Zealand before relocating to the United States.

Lori Carter, Assistant Director and General Counsel, Oklahoma Alcoholic Beverage Laws Enforcement Commission

Lori S. Carter is the Assistant Director and General Counsel for the Oklahoma Alcoholic Beverage Laws Enforcement Commission. She graduated from the University of Oklahoma College of Law with honors in 1996. Prior to joining ABLE, Ms. Carter spent seventeen years with the Oklahoma Attorney General’s Office in various top leadership roles for four attorneys general. In her role as First Assistant Attorney General, Ms. Carter led the staff of almost 200 and managed all aspects of the office including communications, public relations, budget, and legislative and policy initiatives. She oversaw all litigation efforts with outside counsel and with other state attorneys general on a number of state and national policy issues. Ms. Carter represented the Attorney General on local, state, and national task forces and coordinated multi-million dollar litigation and negotiations for the State of Oklahoma. While at the Attorney General’s office, she was instrumental in restructuring the staff, hiring, and compensation packages and additionally coordinated and managed several statewide task forces on issues of statewide importance including the Oklahoma Commission on Opioid Abuse, the SAFE Task Force, the Opioid Overdose Fatality Review Board, the Red River Boundary Commission, the Human Trafficking Task Force, and the Criminal Justice Reclassification Coordination Council, which rewrote the entire Oklahoma felony criminal code.

From 2013-2020, Ms. Carter served as an adjunct professor at the University of Central Oklahoma teaching a course to aspiring law enforcement officers on the legal system and criminal laws. Prior to working for the Oklahoma Attorney General, Ms. Carter worked for an insurance defense litigation firm in Oklahoma City for three years where she fought insurance fraud, defended policyholders, and established a healthcare subrogation business. She has been admitted to practice in all Oklahoma state and federal courts as well as the Tenth Circuit Court of Appeals and the Supreme Court of the United States.

Brannon Denning, Starnes Professor of Law, Cumberland School of Law, Samford University; Advisory Council Member, Center for Alcohol Policy

Denning writes in the area of constitutional law; specifically, he has written on the Commerce Clause and the dormant commerce clause; judicial and executive branch appointments; the constitutional amendment process; foreign affairs and the Constitution; and the Second Amendment. He collaborated with Boris I. Bittker, Late Sterling Professor Emeritus at Yale on Bittker on the Regulation of Interstate Commerce and Foreign Commerce (Aspen Law and Business 1999), and is the sole author of the second edition. In 2016, he published *Guns and the Law: Cases, Materials, and Explanation* (with Andrew Jay McClurg), a casebook published by Carolina Academic Press that covers various aspects of the legal regulation of firearms from the Second Amendment to the laws governing the use of deadly force. Most recently, he has published the sixth edition of *American Constitutional Law: Powers and Liberties*, for which he is the successor author to the late Calvin Massey. He also recently combined two volumes of the previously-published *The Glannon Guide to Constitution Law*, publishing a third edition of *The Glannon Guide to Constitutional Law: Powers and Liberties*. All are published by WoltersKluwer. He also wrote *Developing Professional Skills: Constitutional Law*, an innovative text that furnishes materials allowing students to hone their drafting, analysis, and negotiation skills through constitutional law problems. In addition, he is the co-author of *Becoming a Law Professor: A Candidate's Guide*, a soup-to-nuts guide for the aspiring legal academic. Denning's other writings have been published in *Foreign Affairs*, *Constitutional Commentary*, the *Northwestern University Law Review*, the *William and Mary Law Review*, the *Minnesota Law Review*, the *American Journal of International Law*, the *Wisconsin Law Review*, the *Tulane Law Review*, and *Law and Contemporary Problems* among other journals and periodicals. He was the recipient of the 2008 Harvey S. Jackson Excellence in Teaching Award for upper-level classes and of the Lightfoot, Franklin & White award for Faculty Scholarship, which he won in 2012, 2016, and 2019.

Jim Hall , Former Chairman, National Transportation Safety Board; Center for Alcohol Policy Advisory Council

Mr. Hall began his career in Washington as a member of the staff of Senator Albert Gore, Sr. (D-TN). He subsequently served as a counsel to the Senate Subcommittee on Intergovernmental Relations under Senator Ed Muskie. He maintained a private legal practice in Chattanooga, Tennessee, before serving in the cabinet of Tennessee Governor Ned McWherter. Mr. Hall served as director of the state's Planning Office for five years. As such he was responsible for overseeing the establishment of the Memphis Headquarters for FedEx, the internationally recognized shipping company. In addition to overseeing this large initiative, Mr. Hall handled policy planning and special projects, including heading up planning for the State's Bicentennial Celebration. It was Hall's initiative that resulted in the construction of the Bicentennial Mall in Nashville, one of the city's newest crown jewels. Hall returned to Washington, D.C. to serve as Chief of Staff for Senator Harlan Mathews (D-TN). In 1993, Mr. Hall was nominated by President Clinton to be a Member of the National Transportation Safety Board, and to serve as its Chairman in 1994. He led the Board through January 2001. Hall has for many years been Vice Chairman of the Chattanooga Metropolitan Airport Authority. Mr. Hall is a former member of the Board of

Trustees at the University of Tennessee and the Board of the UC Foundation, and a former member of the Tennessee River Gorge Trust. He was also the Chairman of the Enterprise Center in Chattanooga for eight years, a board member of U.S. Xpress Enterprises, and served on the National Academy of Engineering's Committee on Combating Terrorism and the Aviation Institute Advisory Board of George Washington University. In addition, Mr. Hall served as a member of the External Advisory Board of BP America PLC. Mr. Hall has given congressional testimony before numerous House and Senate committees, including the House Committee on Transportation and Infrastructure (aviation and railroad subcommittees) and the Senate Committee on Commerce, Science and Transportation (transportation and surface transportation/merchant marine subcommittees).

Patrick Lynch, Former Attorney General of Rhode Island; Advisory Council Member, Center for Alcohol Policy

Serving from 2003 to 2010, Patrick C. Lynch was the 72nd person to hold the office of Rhode Island Attorney General since its inception in 1650. A former State prosecutor, he made reducing juvenile crime the centerpiece of his administration, believing that the career criminals of tomorrow start off as the youth offenders of today. A 1987 graduate of Brown University, Attorney General Lynch earned his law degree from Suffolk University Law School. As a Special Assistant Attorney General from 1994 to 1999, he prosecuted cases at every level of Rhode Island's criminal justice system and led the State's prosecution of gang-related offenses. Lynch worked for one of Rhode Island's top law firms until the 2002 election, which capped his first campaign for public office.

Jerry Oliver , Professor of Practice, Watts College of Public Service and Community Solutions, Arizona State University; Center for Alcohol Policy Advisory Council

Former Chief of Police (Detroit, Richmond, and Pasadena) and Arizona alcohol regulator, Jerry Oliver was appointed to the Phoenix Police Department in 1970 before being promoted to Assistant Police Chief in 1988. Oliver was then appointed as Director of Drug Policy before his appointment as Pasadena Police Chief in 1991. He served there for 4 years before becoming Richmond Police Chief in 1995, then Detroit Police Chief in 2002. Following his term as Chief, Oliver was appointed as Special policy Advisor to the Arizona Attorney General in 2004, then appointed by the Governor as Director of the Arizona Department of Liquor Licenses and Control.

Kelly Roberson, Executive Director, Center for Alcohol Policy

In May 2020, the Center for Alcohol Policy named Kelly Roberson as executive director. Roberson brings to the Center her years of experience in policy and marketing from the public and private sectors.

Prior to her work with the Center, Roberson served as policy advisor and communications director in the U.S. House of Representatives where she led a varied portfolio of issues on behalf of the Western Caucus. She cultivated a strong understanding of regulated industries and worked with several members of Congress and their staffs on issues including energy and the environment, land use and resources, water and Native American affairs.

Most recently, Roberson pioneered the role of National Director of Digital Communications for one of the leading bicycle retailers on the east coast. During this time, her passion for building strategic partnerships and relationships combined with her overhaul of the company's digital presence paved the way for exponential growth in both sales and brand awareness.
